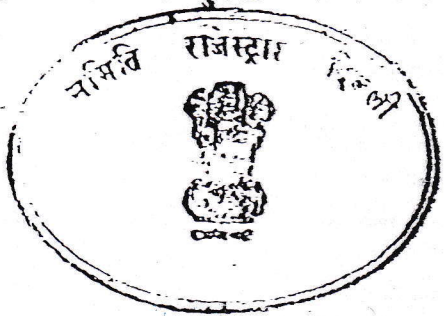

## RULES AND REGULATIONS OF THE BLUEBELLS EDUCATIONAL SOCIETY :

1. **MEMBERSHIP :** "Any person who follows the tenets of Sikh faith and or promotes Sikh culture and or speaks Punjabi and is a resident of Delhi may be selected as member of the Society by the Governing Body with the approval of the Chairperson."
2. **MEMBERSHIP FEE :** The Membership Fee shall be Rs. 10/- per annum.
3. **CONSTITUTION OF THE GOVERNING BODY :** The Governing Body of the Society shall consist of seven members and the Chairman shall be Mrs. G. Soni.
4. **TENURE OF THE GOVERNING BODY :** The Governing Body will be elected for a period of 2 years.
5. **ELECTIONS :** Election to the Governing Body will be held after 2 years and voting shall be by simple majority.
6. **MEETINGS :** A Governing Body will meet at least once a year to review the programme of the Society.
7. **FUNCTIONING OF A MEMBER :** The Governing Body may appoint any member of the Committee to manage and administer the institution under the Society, look after the finance and any other activity necessary in furtherance of its objects. It will manage all Schools under it through a Managing Committee consisting of members elected from among the Governing Body.
8. **MANAGEMENT OF INSTITUTION :** The Society will appoint a Managing Committee to manage and administer the Bluebells School, New Delhi and any other educational institution started by it. The term of the Committee shall be for a year but can be renewed from time to time.
9. **INCOME AND PROPERTY OF THE SOCIETY :** The income and property of the society shall be applied solely towards the promotion of the objects of the Society and no portion shall be paid directly or indirectly or transferred by way of dividend or bonus to its members; provided that nothing herein shall prevent in good faith remuneration under contract to any officer or other persons or servant of the Society or member for service actually rendered to the Society.
10. **OPERATION OF THE ACCOUNTS OF THE SOCIETY :** The accounts of the Society and the institution will be operated by the Chairman and / or such person as the Governing Body may elect for the purpose.
11. **AMENDMENTS OF THE RULES & REGULATIONS :** All amendments to the rules and regulations of the Society will be carried into operation as provided in the registration of societies Act.
12. **QUORUM :** Three persons of the Governing Body shall form Quorum and voting shall be simple majority.
13. **ANNUAL :** An annual general meeting shall be held every year and shall consider the annual report and accounts of the Society.
14. **GENERAL :** All provisions of the Registration of Society Act shall apply to the said Society.  

We, the undersigned members certify that this is a correct copy of the rules and regulation of the Society.
15. **POLICY :** The institution run by the Society shall follow the tenets of Sikh faith and promote Sikh Culture and Punjabi Language.
16. **RAISING FUNDS :** The Society shall be entitled to raise any fund or take any loan or advance from any Bank, institution or person for the purposes of the Society and to furnish any guarantee, pledge or security that may be required and to sign and execute all necessary documents or receipts. The Society shall also be entitled to invest or re-invest in the purchase or undertake sale of property. The Chairperson of the Society shall be authorised to act and execute the necessary documents for and on behalf of the Society.

**17. REMOVAL OF MEMBERS :**

(a) Any member who does not pay subscription on or before 31st March of the year shall automatically cease to be the member of the Society. His name shall thus stand deleted from the membership of the Society.

(b) If any member of the Bluebells Educational Society fails to attend three consecutive meetings of the General or Governing Body as and when held, he may be deemed to have ceased to be a member of the Society as well as a member of the Governing body (if he is a member of the Governing body) and such vacancy may be filled by the Governing body of the Bluebells Educational Society for the rest of the term.

(c) The sub-clause (a) of clause 17 would become affective with effect from 31st March 1984.
